ORDER

The Writ Petition has been filed in the nature of a Writ of Mandamus seeking a direction to conduct survey of the lands of the petitioner in S.F.No.279/9 measuring 1 acre 93 cents at Kupachipalayam, Manmangalam Taluk, Karur District. The petitioner had given a representation on 10.04.2023.

2.Heard the learned Counsel for the petitioner and learned Special Government Pleader for the respondents 1 to 3. The petitioner had also impleaded the respondents 4 to 6, who according to the petitioner, are his adjacent land owners.

3.A direction is given to the first and second respondents to specifically issue notice to the respondents 4 to 6 and in their presence, if there are no objections, conduct survey of the aforementioned lands. If



objections are raised, then reasons should be given as to why survey should not be conducted. The entire exercise should be completed within a period of eight weeks from the date of receipt of a copy of this order.

4.The Writ Petition stands disposed of. No costs.
