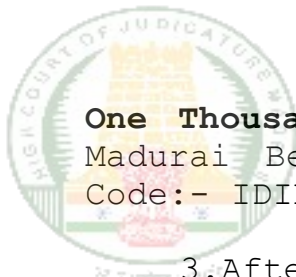
PRAYER IN CRL.RC(MD)SR.No.18306/2023:
