ORDER : This civil miscellaneous petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S I.ROBERT CHANDRAKUMAR, Advocate for the petitioner, while admitting the Civil Miscellaneous Appeal, the court made the following order:-
