ORDER

2. Counter affidavit is filed by the second respondent, in which the following has been stated:

“6. It is submitted that enquiry was conducted with respect to the objection petition of the petitioner and enquiry was conducted and both sides were heard.

7. It is submitted that with respect to the precedent doc. no. 190/1983, the borders of the property in Kela Mel Jathiyadi is altered as 18.5 and Then Vadajathiyadi is altered as 42 and with altered wrong measurements the document is presented for registration. Hence, on the basis of the above said finding, the document in Pending no.97/2021 refused in proceedings no.02/2021.
