2.On the side of the petitioner, it is stated that the villagers of the petitioner proposed to conduct Karagattam program on 11.05.2023, music concert program on 12.05.2023 and Aada Padal cultural program

3.On the side of the prosecution, it is stated that the representation of the petitioner is pending for consideration.

4.In view of the above, this Court is inclined to grant permission only to conduct music concert on 12.05.2023 between 07.00 pm to 09.00 pm and as far as other programmes concerned, this Court is not inclined to grant permission. Accordingly, this writ petition is partly-allowed. No costs.
