### **ORDER**

The learned Special Government Pleader on instructions says that as on date all the 100 houses stand occupied and there is no vacancy. I am therefore not in a position to intervene in favour of the petitioner. Direction is given to the District Collector, Theni District as well as the first respondent herein to consider the case of the writ petitioner since he is said to be a homeless person.
