For Anticipatory Bail in Crime No.13 of 2023 on the file of the Respondent Police

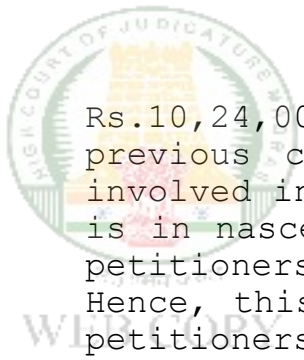
ORDER : The Court made the following order :-

The petitioners/Accused, apprehending arrest at the hands of the respondent police for the alleged offence punishable under Sections 406, 465, 467, 468, 471, 420, 120(B) of I.P.C, in Crime No.13 of 2023, on the file of the respondent police, seeks anticipatory bail.

2. The case of the prosecution as per the defacto complainant is that the accused persons had conspired together and cheated a sum of Rs.89,23,894/- from the defacto complainant company. Hence, the complaint.

3. Heard. Perused the materials including the first information report.

4. It is seen that there are totally 10 accused in this case. The petitioners are arrayed as A2 and A3. Both are brothers. So for the petitioners have cheated the victim to the tune of



Rs.10,24,000/-. More over the first petitioner was involved in the previous cases of similar nature and the second petitioner also involved in two previous cases of similar nature. The investigation is in nascent stage. Therefore, the custodial interrogation of the petitioners are necessary for the investigation to proceed further. Hence, this Court is not inclined to grant anticipatory bail to the petitioners.

5. Accordingly, this Criminal Original Petition stands dismissed.
