ORDER

This petition has been filed seeking for a direction to the learned III Additional Sessions Judge for PCR Court, Madurai to consider the petitioner's bail application on the same day of filing in Crime No.92 of 2023 on the file of the 2nd respondent police.

2. In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and also taking into consideration the possibility of misusing the pious intention of the Parliament against innocent persons, there shall be a direction to the III Additional Sessions Judge for PCR Court, Madurai, to consider the petitioner's bail application, preferably on the same day of his surrender in connection with Crime No.92 of 2023 on the file of the second respondent and pass appropriate orders in accordance with law after affording due opportunity to the victim under Section 15(a) of the SC/ST Act. The petitioner shall surrender before the concerned jurisdictional Court within a period of fifteen days from the date of the receipt of a copy of this Order.
