In the affidavit filed in support the present Transfer Civil Miscellaneous Petition, the petitioner has stated that the petitioner is living with her mother aged about 75 years and that her father passed away. It is further stated that the petitioner depends on her brother who is employed in a private company at Pudukkottai and as the petitioner has no job, she depends on her brother for her daily meals and therefore cannot burden her brother.

4. It is further stated that the distance between the Coimbatore and the Pudukkottai is around 267 kms. and therefore, the petitioner will have to travel about 534 kms. for each and every hearing.
