ORDER : The Court made the following order :-

While passing the order dated 18.05.2023, the petitioner was granted interim anticipatory bail for a period of three months. In the meantime, the parties are directed to appear before the District Registrar, Madurai South Region, Madurai District for initiating action under Section 77 A of the Registration Act, which is stated to be pending.
