Prayer in CRL MP(MD). 4070/ 2023 :

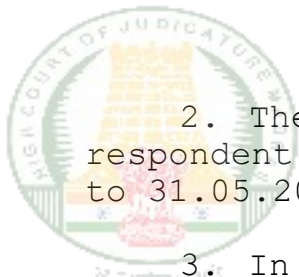

To call for the records pertaining to the conviction order passed in Crl.A.No.42 of 2020 on the file of the learned V Additional District and Sessions Judge, Madurai dated 11.01.2023 by confirming the conviction sentence and also enhancing the fine amount passed by the learned Judicial Magistrate Court-V, Madurai dated 17.02.2020 in C.C.No.206 of 2016 and set aside the same.
