PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.213 of 2022 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioner, who apprehends arrest at the hands of the respondent police for the alleged offences punishable under Sections 294(b), 324 and 506(ii) of IPC, in Crime No.213 of 2022 on the file of the respondent police, seeks anticipatory bail.

2.The case of the prosecution is that the petitioner along with other accused persons said to have threatened the defacto complainant with dire consequences and also attacked him and caused injury. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the petitioner is innocent person and he has not committed any offence as alleged by the prosecution. He would further submit that this is the fourth anticipatory bail application. Earlier applications were dismissed and disposed of by this Court.



4.The learned Government Advocate (Crl.Side) would submit that the petitioner is having 5 previous cases and he is a History Sheeted.

5.Considering the facts and circumstances of the case and also considering the fact that already there was a direction to the petitioner to surrender before the concerned Court or before the respondent police, this Court is not inclined to interfere with the order passed by this Court 18.10.2022.

6.Accordingly, this Criminal Original Petition is dismissed.
