3. Considering the facts and circumstances of the case, the condition imposed by this Court in Crl.O.P(MD)No.5739 of 2023 is modified to the effect that the petitioner shall deposit a sum of Rs.10,000/- to the credit of Crime No.225 of 2023 before the



learned Judicial Magistrate No.V, Madurai and on production of proof/acknowledgement the learned Judicial Magistrate No.V, Madurai shall accept the sureties furnished by the petitioner.
