2. When the matter is taken up for hearing the learned Additional Public Prosecutor appearing for the official respondents represented that the fifth respondent gave complaint before the fourth respondent and C.S.R. No.233 of 2021 was given. Based on that complaint fourth respondent called the petitioner as well as the private respondents for enquiry. Apart from that they have not
