ORDER

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai has issued a circular memorandum in Rc. 007301/Genl.I (1)/2019 dated 09.04.2019 along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting programme. Therefore, the writ petitioner is directed to file an undertaking affidavit incorporating the date and time of the Kabadi tournament before the third respondent and on such filing, the third respondent is hereby directed to consider the petition of the writ petitioner dated 12.05.2023 and pass orders in accordance with law.

6. With the above directions, this Writ Petition stands disposed of.
There shall be no order as to costs.
