ORDER

2. When a show cause notice was issued to the petitioner herein based on an adverse police verification report against the petitioner herein for the involvement in Crime No.146 of 2021 for the offence under Section 379 IPC, the petitioner has approached this Court seeking for issuance of writ of mandamus directing the first respondent to issue clearance certificate and allow the petitioner to travel abroad.

3. The petitioner possesses a valid Passport No.R3060942 and VISA has also been issued to him.

4. The learned Additional Government Pleader representing the second respondent submitted that the investigation in Crime No.146 of

In the light of the submissions made, the petitioner is granted liberty to give explanation to the show cause notice dated 17.05.2023 issued by the first respondent herein within thirty days from the date of receipt of a copy of this order. On receipt of the same, the first respondent herein shall consider it on its own merits and pass appropriate orders in accordance with law within a period of two weeks therefrom.

7. With the above directions, the Writ Petition stands disposed of.
There shall be no order as to costs.
