3.Considering the reasons stated in the petition, this petition is ordered and the time for depositing a sum of Rs.7,50,000/- by the petitioner before the respondent is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail already granted by this Court shall stand cancelled.
