This petition has been filed to modify the conditions imposed on the petitioners in Crl.MP.No.2213 of 2023 dated 13.04.2023 by the learned Principal Sessions Judge, Thoothukudi.

2.The learned counsel for the petitioner submitted that there is civil dispute between the parties and a suit in O.S.No.84 of 2019 is also pending. He further submitted that the first petitioner is a senior citizen and the third petitioner is a college student. Hence, he seeks modification of the conditions.
