ORDER

This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Certiorarified Mandamus, calling for records pertaining to the impugned order passed by the 2nd respondent dated 06.06.2023 and quash the same and direct the 2nd respondent to grant permission and necessary protection to perform the cultural program (ie) Adal Padal on 10.06.2023 at 07.00 pm to 10.00 pm in the eve of Arulmigu Sri Madu Adaikalamkatha Aman Kovil Thiruvizha 6th Mandagapadi at Mathakovil Street, Virachilai Post, Pudukottai District.

4. The learned counsel appearing for the writ petitioner submitted that festival for the temple, by name, “Arulmigu Sri Madu Adaikalamkatha Aman Kovil Thiruvizha 6th Mandagapadi at Mathakovil Street, Virachilai Post, Pudukottai District”, is going to be held on 10.06.2023. Subsequent to the same, in order to conduct a cultural programme on 10.06.2023, they sought permission of the police by giving a representation. But, the second respondent has considered and rejected the said representation. Challenging the same, the writ petitioner has come before this Court for the above said relief.

5. Perusal of impugned order shows that since the cultural program is to be conducted in Pudukkottai District, after getting permission from this Court, permission may be granted to the petitioner by the second respondent.

6. The learned Government Advocate (Crl.Side) appearing for the respondents police submitted that the respondents police are ready to consider the petitioner's representation, if the petitioner give a fresh representation by incorporating alternative place for conducting cultural programme.

7. The second respondent Police is present before this Court and state that no such previous occurrence took place in the village, when the similiary event was conducted in the yester years.

8. At this juncture, the learned counsel appearing for the writ petitioner would submit that they are ready to give a fresh representation before the concerned respondent police by incorporating place.

9. The petitioner is hereby directed to give fresh representation to the second respondent by incorporating place and on such representation, the second respondent is hereby directed to consider the same and pass orders immediately following the order following the order of the Hon'ble Division Bench of this Court passed in the case of ***C.Sathasivam Vs. The Superintendent of Police, Trichy District and another***, in ***W.P.(MD).No.12535 of 2023, dated 24.05.2023*** and in the light of the circular of the Director General of Police, Tamil Nadu, Chennai in Rc.007301/Genl.I (1)/2019, dated 09.04.2019.
