ORDER

This petition is filed seeking for a direction to the respondent police to provide adequate police protection to the petitioner from the unofficial respondents herein.

2.It is submitted by the learned counsel for the petitioner that the unofficial respondents intend to purchase the landed property belonging to the petitioner for a lesser price than the market value, for which the petitioner did not agree, on which the unofficial respondents stated to have abused the petitioner in filthy language and threatened her. The petitioner stated to have sent a complaint by post to the respondent No.1, however and no action has been taken. Hence, this petition.

3.Essentially, the issue between the petitioner and the unofficial respondents is purely civil in nature, thereby the petitioner should have
