ORDER

The Writ Petition has been filed in the nature of mandamus seeking a direction to the 2 and 3 respondents, the Revenue Divisional Officer, Aundipatti Taluk, Theni District and the Tahsildar, Aundipatti Talauk, Theni District, to issue patta in the name of the petitioner for the lands in Survey No. 449/1G, Mayiladumparai Village, measuring to an extent of 3 acres.
