from the date of receipt of a copy of this order.

2) On such surrender along with notice served
to the defacto complainant, the concerned
Judge shall consider the bail application filed
by the petitioner and pass orders on merits on
the same day of his surrender, after hearing the
defacto complainant by complying with
Section 15A(3) of the Act. The trial Court shall
taken into consider the previous antecedents of
the petitioner while passing orders on merits.

5. With the above observation, this Criminal Original Petition is
disposed of.
