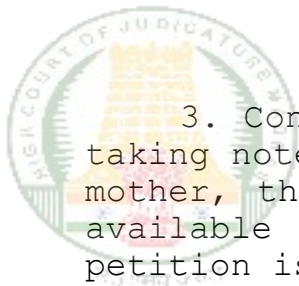
Prayer in CRL RC(MD). 130/ 2023 :
