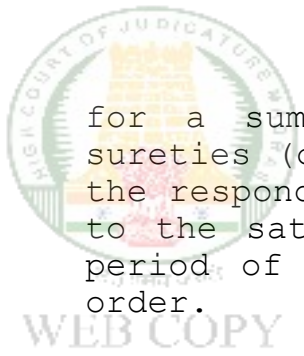

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of M/S.MOHIDEEN BASHA N, Advocate for the petitioner and of M/S.THANGA ARAVINDH.B, Government Advocate(Crl.side) on behalf of the Respondent, the court made the following order:-

This Criminal Miscellaneous Petition has been filed to modify the condition in the order in Crl.O.P.(MD)No.8043 of 2023 dated 27.04.2023 that the petitioners shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties (common surety)each for like sum to the satisfaction of the concerned Magistrate.

2.Considering the facts and circumstances of the case, the condition already imposed on the petitioner is modified to the effect that the petitioners shall execute a bond



for a sum of Rs.10,000/- (Rupees Ten Thousand only) to provide sureties (common surety) each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, within a period of two weeks from the date of receipt of a copy of this order.

3. Accordingly, the Criminal Miscellaneous Petition is allowed.
