The petitioner/A1 has filed this petition to quash the FIR in Crime No.296 of 2021 on the file of the first respondent, wherein he is said to have committed the offence under Sections 147, 294(b), 323 and 506(2) of IPC.

2. The case of the prosecution is that on 10.07.2021, when the defacto complainant was returning to home in his TVS Appachi Bike, the petitioner along with other accused in a drunken mode blocked him in the road. The second respondent asked the petitioner and others to leave the way, at that time, they scolded the defacto complainant with filthy language and also attacked him. Hence, the complaint.
