ORDER

This petition is filed seeking for a direction to the respondents 1 and 2 to give police protection to the life and limb of the petitioners from the 3rd respondent.

2.It is submitted by the learned counsel for the petitioners that the 3rd respondent caused damage to the property of the petitioners, thereby, the petitioners lodged a complaint before the respondent Police on 24.04.2023.
