The petitioner, seeking production of her daughter, namely, Essakiammal, aged about 17 years, has filed this Habeas Corpus Petition.

2.Today, when the matter is taken up for hearing, the respondent Police has produced the detainee, namely, Essakiammal, before this Court. She has stated that she was studying in the 1st year degree course and at that time, the 3rd respondent being the relative of the detainee girl, had taken her some outstation and from where the respondent Police has rescued her and brought before this Court.
