4. The First Information Report was filed only on 03.06.2023 and absolutely there is no life threat at the hands of the above said private respondents to the petitioner. The third respondent is directed to conduct enquiry by calling the petitioner and as well as the private respondents



immediately and to dispose the representation that was made by the petitioner within a week from the date of appearance of the parties.

4. With the above said direction, this Criminal Original Petition is disposed of.
