This criminal original petition has been filed seeking to quash the FIR in Crime No.301 of 2022 on the file of the first respondent Police.

2.The contention of the petitioner is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.301 of 2022 for the offences punishable under Sections 294(b), 506(1) and 420 of IPC.

3.When the matter is taken up for hearing, the learned Additional Public Prosecutor would submit that after completing the investigation final report has been filed before the learned Judicial Magistrate No.II, Thanjavur through e-filing and the same has not been taken cognizance so far. Hence, the prayer sought for in this petition has become infructuous.
