This petition has been filed seeking to quash the impugned FIR in Crime No. 4 of 2022 on the file of the 1st respondent police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.4 of 2022 for the offences punishable under Sections 147, 148, 294(b), 341, 442, 447, 427, 506(ii) of IPC and Section 4 of TNPHW Act, 2002, against the petitioners.
