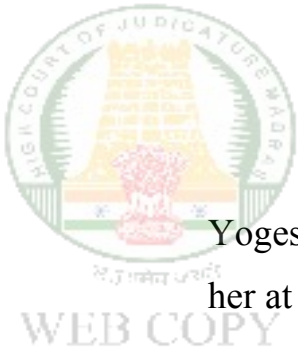

This Habeas Corpus Petition has been filed to direct the respondents to produce the petitioner's daughter-in-law, namely, Yogeswari, daughter of Nagarajan, aged about 20 years, before this Court and set her at liberty.

2. Today, when the matter is taken up for hearing, the respondents Police has produced the detainee girl along with her mother. The detainee girl has stated that she has completed +2 and is doing the Teacher Training Course and she left the parental home some time back and after realizing her mistake, now she has come forward to join with her mother.

When we specifically asked that was there any marriage taken place or solemnized between the detinue and the son of the petitioner who claims to be the mother-in-law of the detinue, the detinue girl stoutly refuted such allegation and stated that she has never married anyone including the son of the petitioner and she wants to go with her mother, namely, K.Saraswathi.

4. The said statement made by the detinue girl is recorded.

5. Recording the same, the detinue girl since is not in illegal custody and has returned back to her mother, we close this Habeas Corpus Petition.
