The said representation was transferred to the Thasildar, Usilampatti for convening the Peace Committee Meeting.

3. In view of the above said development, the Thasildar, Usilampatti, Madurai District is suo motu impleaded as 6th respondent in this petition. The petitioner is directed to abide by the resolution to be adopted in the Peace committee Meeting. Let the Peace Committee Meeting be convened by the 6th respondent, within a week from the date of receipt of a copy of this order.

4. With the above direction, this Writ Petition is disposed of.
