Prayer in CMP(MD) . No.1977 of 2023:-

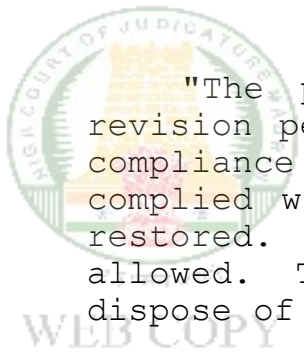
