2.Heard the learned counsel for the petitioners and the learned Government Advocate(Crl.side) appearing for the respondent.

3.Considering the reasons stated in the petition, this petition is ordered on condition that the petitioners shall pay a cost of Rs.5,000/- to the Mediation and Conciliation Centre, attached to this Bench. On such payment of cost, time for surrender by the petitioners before the concerned Court and executing the sureties is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail already granted by this Court is to be stand cancelled.



4. Accordingly, this Criminal Miscellaneous Petition is allowed.
