"Heard the learned counsel on either side.

2.The petitioner wants this Court to direct the fourth respondent to survey the petition mentioned lands and based on the survey result issue independent patta. The prayer is not contested by the respondents. They only seek time. The said request made by the respondents cannot be rejected. I direct the fourth respondent to complete survey of the petition mentioned lands within a period of five months from the date of receipt of a copy of this order. Based on the survey result, patta shall be issued in favour of the petitioner immediately thereafter.

3.The writ petition is allowed on these terms. No costs. Consequently, connected miscellaneous petitions are closed. "
