ORDER : The Court made the following order :-

The petitioners/accused, who apprehend arrest at the hands of the respondent police for the alleged offences punishable under Sections 147, 294(b), 323 and 506(ii) IPC, in Crime No.170 of 2023 on the file of the respondent police, seek anticipatory bail.

2. The case of the prosecution is that on 01.06.2023 during marriage function some of the relatives of the bride performed bike stunt within the church campus and when the same was questioned by the defacto complainant the petitioner herein said to have abused and assaulted him and also threatened with dire consequences. Hence, the complaint.

3. Heard. Perused the materials available on record including the First Information Report.first petitioner is having 5 previous cases and the second petitioner is having 4 previous cases and the fourth



petitioner is having 3 previous cases.

4. Taking into consideration the facts and circumstances of the case and also the previous bad antecedents of the petitioner, this Court is not inclined to grant anticipatory bail to the petitioners.

5. Hence the petition stands dismissed.
