2.Today, when the matter is taken up for hearing, the learned Additional Public Prosecutor submitted that on 23.02.2022, this Court directed the respondent to execute the Non Bailable Warrant issued as against the accused in STC.No.302 of 2016. However, while pending the warrant, both the parties entered into compromise and settled the entire issue. Therefore, the Non Bailable Warrant issued against the accused become infructuous.

3.Recording the submission of the learned Additional Public Prosecutor, this Contempt Petition stands closed.
