Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus to direct the 1st respondent to cancel the Patta in Patta No. 137 in respect of the property in survey number 80/4A2B to the extent of 0.46.0 situated at Kannirajapuram village, Ramanathapuram District and to issue Patta to the petitioner on the basis of the representation dated 27.05.2023 within a stipulated time fixed by this Court.

ORDER

The writ petition has been filed in the nature of a mandamus seeking a direction to the first respondent / District Revenue Officer, to cancel the patta in Patta No.137 with respect to property in Survey No.80/4A2B measuring 0.46.0 acres in Kannirajapuram, Ramanathapuram District and to issue patta in the name of the petitioner herein. The petitioner is a senior citizen. The petitioner had given representation in this regard.

2. Learned counsel for the petitioner stated that though the patta today stands in the name of Kasiraman and Lakshmana Perumal, Malarkodi and Amutha, they had executed a rectification deed. The petitioner had also filed the earlier writ petition to cancel the sale deed. After that the said individuals have executed a rectification deed. Now the patta will have to be cancelled and the name of the petitioner will have to be incorporated in the revenue records.

3. The first respondent is directed to issue notice to the petitioner and also to the aforementioned individuals in whose names the patta today stands

and after getting necessary clarification, proceed to do the needful. The entire exercise may be completed within a period of 12 weeks from the date of receipt of a copy of this order. The first respondent may keep in mind that the petitioner is a senior citizen.
