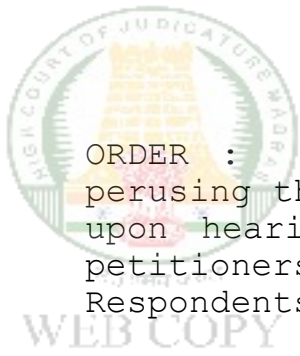

Prayer in WP(MD). 14358/ 2023 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records on the file of the 4th respondent pertaining to the selection list dated 23.05.2023 and to quash the same as illegal and consequently direct the 4th respondent to prepare a fresh list selecting the petitioners studying LKG onwards in the 4th respondent school.



ORDER : This petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of SC.HEROLD SINGH, Advocate for the petitioners and of Mr.M.RAMESH, Government Advocate on behalf of the Respondents No.1 to 3, the court made the following order:-

Even though the petition in W.M.P(MD) No.12167 of 2023 has been filed, both the petitioners have instituted a single Writ Petition relating to their children for admission in the fourth respondent school. They both have different cause and therefore, two separate Writ Petitions have alone to be filed.

2. This Writ Petition filed by Yakesh son of Murukesa Mani, is taken on record. The second petitioner may file a separate writ petition.

3. Accordingly, the W.M.P(MD) No.12167 of 2023 is rejected.
