3. The learned Standing Counsel appearing on behalf of the Waqf Board submitted that on scrutiny of the records, it is found that as per the proforma, the property in question belongs to the Waqf Board.

4. In view of the above, there shall be a direction to the third respondent to consider the objection submitted by the petitioner, before entertaining any document pertaining to the property situated at S.Nos.136/1, 146/3 measuring to an extent of 1.66 acres at Sathirapatti, Sattur Taluk, Virudhunagar District. The third respondent is bound to consider the objections, since the property in question is stated to be a Waqf property and the same is also confirmed by the Waqf Board.

5. This writ petition is disposed with the above directions. No costs. Consequently, connected miscellaneous petition is closed.
