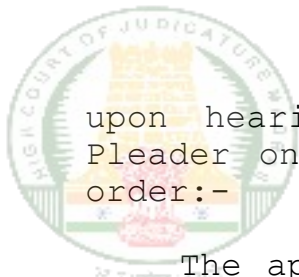
Prayer in WA(MD) SR No.33303 of 2023:
