PRAYER: Petition filed under Article 226 of the Constitution of India to issue a writ of Habeas Corpus, calling for the entire records connected with the detention order passed in M.H.S.Confdl No.20/2023 dated 17.02.2023 on the file of the second respondent herein and quash the same and direct

the respondents to produce the detenu or body of the detenu i.e., the petitioner's son namely Praveenkumar @ Praveen, aged about 23 years S/o.Muthuramalingam, now detained at the Central Prison, Palayamkottai, Tirunelveli District before this Court and set him at liberty forthwith.

ORDER

(Order of the Court was made by M.S.RAMESH,J.)

The petitioner is the father of the detenu viz., Praveenkumar alias Praveen, aged about 23 years, S/o.Muthuramalingam. The detenu has been detained by the second respondent by his order in M.H.S.Confdl No.20/2023 dated 17.02.2023 holding him to be a "Drug Offender", as contemplated under Section 2(e) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. We have heard the learned counsel appearing for the petitioner and the learned Additional Public Prosecutor appearing for the respondents. We have also perused the records produced by the Detaining Authority.

3. Though several grounds have been raised in the Habeas Corpus Petition, the learned counsel appearing for the petitioner would mainly focus her argument on the ground that the detaining authority, after being aware of the fact that there was no bail application filed by the detenu, came to the conclusion that there is a real possibility of the detenu coming out on bail by relying upon the order passed in CrI.O.P.(MD).No.11441/2022 dated 27.07.2022. The learned counsel therefore submitted that the order that was relied upon by the detaining authority was not similar and on that score, the detention order is liable to be interfered with.

4. The learned Additional Public Prosecutor strongly opposed the Habeas Corpus Petition by filing his counter.

5. On carefully going through the detention order, the detaining authority was aware of the fact that no bail application was filed by the detenu. However, the detaining authority took into consideration the order passed in CrI.O.P.(MD).No.11441/2022 dated 27.07.2022 and came to the conclusion that there is a likelihood of the detenu coming out on bail. Perusal of the order shows that the contraband involved therein is

intermediate quantity of 14 Kgs of Ganja. However, in the present case, the contraband involved is commercial quantity of 100 Kgs of Ganja and hence, the bail order that was relied upon by the detaining authority cannot be considered to be a similar one.

6. In view of the above, the detention order suffers from non application of mind and the same is liable to be interfered with by this Court. The impugned detention order is, therefore, liable to be quashed.

7. In the result, the Habeas Corpus Petition is allowed and the order of detention in M.H.S.Confdl No.20/2023 dated 17.02.2023 passed by the second respondent is set aside. The detenu, viz., Praveenkumar alias Praveen, S/o.Muthuramalingam, aged about 23 years, is directed to be released forthwith unless his detention is required in connection with any other case.
