This criminal original petition has been filed seeking to quash the FIR in Crime No.148 of 2022 on the file of the 1st Respondent Police.

2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.148 of 2022 for the offences punishable under Sections 294(b), 232, 506(i) of IPC and Section 4 of Tamil Nadu Prohibition of Women Harassment Act, 2002.

3.When the matter is taken up for hearing, the learned Government Advocate (Crl. Side) would submit that after completing the investigation final report has been filed before the learned Additional Mahila Court, Magisterial Level, Dindigul, and the same was taken cognizance in C.C.No.342 of 2023. Hence, the prayer sought for in this petition has become infructuous.

4.Since the final report has been filed before the concerned Court, the petitioner can workout his remedy through appropriate proceedings,
