ORDER

Heard the learned counsel on either side.

2. The writ petitioner was working as Senior Grade Tradesman in the respondent Corporation. He retired on 30.06.2022. However, his terminal benefits were settled on 30.05.2023. It is well settled that for such belated settlement, the retired employee is entitled to interest. I therefore direct the respondent Corporation to pay interest to the writ petitioner computed at the rate of 6% per annum on the belated disbursement from the date of retirement till date of settlement. The interest amount shall be paid within a period of twelve weeks from the date of receipt of a copy of this order.

3. This writ petition is allowed accordingly. There shall be no order as to costs.
