3. The learned counsel appearing for the petitioner would submit that for very similar representation that was made by the neighbouring village people, permission was granted by the second respondent, on that ground, this petition has been filed.

4. Even though the second respondent is present before this Court, stated that the proposed place is National Highways road, so the petitioner has to obtain permission from the National Highways' authorities. But however, the learned counsel for the petitioner would submit that the proposed place is a village panchayath road, for which, the third respondent is the competent authority to grant permission.

5. After ascertaining the place, which is proposed to put up the above said Arch, the second respondent is directed to consider the representation of the petitioner and dispose the same immediately on its own merits, by taking into account of the ground situation by making enquiry with the third respondent and other competent authority.
