4.Accordingly, the Criminal Miscellaneous Petition is allowed.

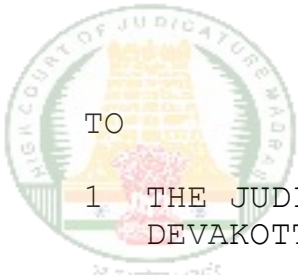
