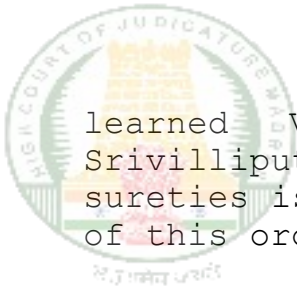

3.Considering the reasons stated in the affidavit filed in support of this petition, the condition already imposed on the petitioner in condition No.(ii) in Crl.M.P.No.2648 of 2023, by the Vacation Sessions Judge, Virudhunagar District at Srivilliputtur, dated 31.05.2023, is modified to the effect that "the petitioner shall report before the respondent police daily at 10.30 a.m., for a period of two weeks and thereafter as and when required for interrogation" In respect of other condition, the order of the



learned Vacation Sessions Judge, Virudhunagar District at Srivilliputtur, shall remain unaltered. The time for executing the sureties is extended by two weeks from the date of receipt of a copy of this order.
