The learned counsel appearing for the petitioner would submit that the petitioner has lodged complaint through online before the second respondent for misplacing of his original sale deed Document No. 636/1988 dated 01.04.1988, situated at Manivilan, (Ward B Pallathiayal), Aranthangi, Pudukkottai District. He would further submit that the petitioner has also made paper publication with regard to the missing of original documents.

Considering the above, the second respondent police is directed to conduct enquiry ensuring the said documents have not been deposited for any purpose, following the circular issued by the Director General of Police within a period of three months from the date of receipt of a copy of this order. Depending upon the outcome of the above said enquiry, the petitioner can workout her remedy through appropriate proceedings, if not satisfied.

5. With the above direction, this Writ Petition stands disposed of.
