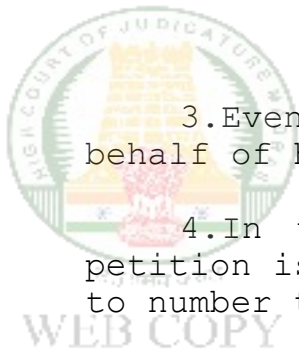
Prayer in CRL.RC.(MD).No.SR.25181 of 2022:
