ORDER

The Superintendent of Police, Trichy District and another***, in ***W.P. (MD).No.12535 of 2023, dated 24.05.2023*** and in the light of the circular of the Director General of Police, Tamil Nadu, Chennai in Rc. 007301/Genl.I (1)/2019, dated 09.04.2019.
